Ad Hoc Committees

Council Operating Procedure 8 outlines the process for creating, operating, and terminating Ad Hoc Committees. Ad Hoc Committees are created to address specific or short-term issues and are intended to be in place for a limited duration. The Committees are created and terminated by vote of the Council. The Council should review the current list of Ad Hoc Committees and dissolve Committees who have accomplished their charge (Agenda Item J.3, Attachment 1). Where appropriate, the Council may update a committee's charge to align with its current objectives.

In response to <u>Executive Order 14173</u>, Chair Pettinger removed all members from the Equity and Environmental Justice Committee. In March, the Council should act to formally disband the Committee consistent with the Executive Order.

The National Marine Fisheries Service is no longer expected to issue a proposed rule to modify Standard Guidelines (NS) 4, 8, and 9 which ensure fair and equitable allocation of fishery resources (Standard 4), consider the economic impact of management decisions on fishing communities (Standard 8), and minimize bycatch and bycatch mortality (Standard 9). Accordingly, the Council should act to dissolve the NS Guideline Committee.

Council Operating Procedures

There were no changes to the Council Operating Procedures submitted for the advanced briefing book production.

Council Action:

- 1. Appoint representatives to the EAS.
- 2. Appoint representatives to the GAP.
- 3. Appoint representatives to the HMSAS.
- 4. Provide guidance to staff regarding the vacant GAP and SSC positions.
- 5. Review existing Ad Hoc Committees and determine whether to maintain, dissolve, or revise their charges, as appropriate.
- 6. Disband the EEJC and NS Guideline Ad Hoc Committees.
