Definitions I

New Management Measures: (FMP §6.2)

- Impacts have not been previously analyzed
- Have not been through rulemaking (implemented in regulation).

Routine Management Measure (FMP §6.2.1.1)

- Impacts have been analyzed
- Specified as routine by Council and in regulation (§660.60(c))
- Measures likely to be adjusted on an annual basis or more frequently



Definitions II

"The List"

- All previously proposed management measures (GMT Rpt 2)
- GMT summarizes each proposal (GMT Rpt 1)

Prioritized Measures

- Council identified measures for development
- Scheduled under Future Council Meeting planning
- Not bound to prioritize



Background

1. Goal was to replace Biennial Omnibus

2. Concept

- Annual agenda item
- Transparency in management measure prioritization process
- Opportunity for constituents to propose management measures
- Opportunity to prioritize groundfish work on annual basis in in light of all Council commitments

3. Process initiated March 2019



Process & Responsibilities

Constituents

- Propose new measures to GAP, GMT, and/or Council
- In the past, no timeline, can be proposed at each meeting


GMT & GAP (in March)

- Review new proposals from constituents
- Review and propose List revisions/updates to Council
- GMT/GAP may recommend proposals for prioritization

Council (in March)

- Adopts updated proposed management measure list
- May adopt new proposals to list
- May prioritize measures for development
