PHASE 2 STOCK DEFINITIONS: SUMMARY OF DECISION POINTS FOR JUNE 2025

This document is intended to provide a highly summarized synopsis of the Phase 2 Stock Definitions action. The role of the following is to supplement the analyses in Attachment 1 and Supplemental Attachment 2 and is meant to simplify the decision points of this action for the Pacific Fishery Management Council (Council) and the Advisory Bodies.

In brief, there are several main decision points for the Council to consider. The first is to adopt the final preferred alternative (FPA) for 47 groundfish species. The second is to adopt a preliminary preferred alternative (PPA) for 39 groundfish species (hereinafter, species). The third is to consider the Groundfish Management Team's (GMT) analysis on ecosystem component (EC) species and determine if they need further evaluation.




Figure 1. Overview of the Range of Alternatives and Options for this action. Species under Alternative 1 *ARE* in need of conservation and management, species under Alternatives 2 & 3 *ARE NOT* in need of conservation and management

The Council is considering three alternatives and three options under Alternative 1 (Figure 1):

- Alternative 1 would identify the species as in need of conservation and management in the exclusive economic zone (EEZ) and under consideration*
- Alternative 2 would identify the species as not in need of conservation and management in the EEZ, remove the species from the FMP and, thus, Federal Management
- Alternative 3 would identify the species as not in need of conservation and management in the EEZ and designate them as an EC species, thus remaining in the FMP.

<u>Under Alternative 1</u>, the Council is considering three stock definition Options:

- Option 1: Single stock, single area
- Option 2: Two stocks, two areas
- Option 3: Three stocks, three areas.

1.1 FPA Decision Point (Attachment 1)

The first task for the Council is to consider adoption of its FPA Alternative for 47 species. The Council adopted Alternative 1 for the 47 species shown in Table 1 as PPA. Alternative 1 would identify these species as in need of conservation and management in the EEZ. The species would continue to be actively managed by the Council.

Stock Definition Options:

If the Council adopts Alternative 1 for any or all of these species, the next step is to adopt FPA stock definitions for those species. Of the species in Table 1, 19 have had stocks defined and those definitions are not under reconsideration at this time. Therefore, of the 47, stocks for 28 need to be defined as part of this action (Table 2).

A total of 23 species were considered only under Option 1, four species under Options 1 and 2, and one species under all Options (Table 3). The Council adopted Option 1 as PPA for all species. The Option 1 stock definition for 24 species would be coastwide, three species would be California-only stocks, and one species would be an Oregon/Washington stock.

If the Council is undecided for any of these species, those species should be evaluated under the 10 Factors found at §600.305(c). Of note, Council staff determined one species, harlequin rockfish, could be a candidate for either Alternative 2 or Alternative 3 based on Council discussion and Advisory Body reports at the March 2025 meeting. As such, Council staff also evaluated harlequin rockfish under these 10 factors.

1.2 **PPA Decision Point** (Supplemental Attachment 2)

The Council directed staff to analyze 39 species under the 10 factors at §600.305(c) to support a PPA at this, the June, Council meeting. The next step is for the Council to adopt a PPA among Alternatives 1-3 for these 39 species (Table 4), with the option to also adopt a PPA for harlequin rockfish (see above).

If the Council adopts Alternative 1 for any or all of these species, the next step is to adopt PPA stock definitions for those species. Of the species in Table 4, three species (black, copper, and quillback) have had stocks defined and those definitions are not under reconsideration at this time. Therefore, of the 40 species, stocks for up to 37 could be defined as part of this action, depending on how many species are adopted under Alternative 1.

1.3 EC Review (GMT Report 1)

The Council directed evaluation of the current list of EC species in relation to the Phase 2 process. The GMT was tasked with evaluating these species. Their report, <u>Agenda Item E.6.a, GMT Report</u> 1, June 2025, provides detailed information regarding these species.

It is important to note that reconsideration of the current EC species is not part of the scope of this action. In the event the Council were to consider moving any of these species under active management, a full 10 Factor evaluation would need to be completed. In the scoping of Phase 2 (Agenda Item I.8, Attachment 1, September 2024), Phase 2 is specific to the currently managed species and appropriate revisions to the stock complexes. These items must be addressed to align the FMP with the Magnuson-Stevens Act and its National Standards. Given the workload associated with Phase 2, Staff recommends reconsideration of EC species be undertaken in a subsequent Phase.
