

FUTURE COUNCIL MEETING AGENDA AND WORKLOAD PLANNING

This agenda item is intended to refine general planning for future Pacific Fishery Management Council (Council) meetings with a focus on finalizing the proposed agenda for the September 2026 Council meeting in Vancouver, Washington and the November 2026 Council meeting in Garden Grove, California. The following attachments are intended to help facilitate Council planning:

1. Preliminary Year-at-a-Glance (YAG) - An abbreviated display of potential agenda items for the next five Council meetings (Attachment 1). Several agenda items affect multiple Fishery Management Plans (FMPs) and are labeled “Cross FMP.” Shaded items on the YAG indicate uncertainty regarding the availability of materials needed for the advanced briefing book, which is essential for supporting Council action. The uncertainty is related to the Council and National Marine Fisheries Service (NMFS) staff capacity and complexity of the action. The Executive Director will suggest removing the shading from an item if or when clarity arises regarding staff capacity to commit to the agenda item as scheduled. The second page of Attachment 1 includes links to the acronyms glossary and Advisory Body meeting schedule and formats.
2. Quick Reference - A preliminary proposed abbreviated display of the September and November 2026 Council meeting agendas (Attachments 2 and 3, respectively).

The Executive Director will assist the Council in reviewing the proposed agenda materials and discussing any other matters relevant to Council meeting agendas and workload. After considering supplemental material provided at the Council meeting, and any reports and comments from advisory bodies and public, the Council will provide guidance for future agenda development, the proposed September and November Council meeting agendas, and workload priorities for Council staff and advisory bodies.

- 3. Identify priorities for advisory body workload considerations.**
